

# The project «Dublin, shared Europe» was funded with the support of the European Union under the Programme "Europe for Citizens"

Six events have been carried out within this project:

### **Event 6 – PREPARATORY ACTIVITIES: KICK-OFF MEETING**

**Participation:** The event involved 21 citizens, including 5 participants from Italy, 3 from the city of Spoleto and 2 from the city of Camerino; 5 participants from the city of Novo Mesto (Slovenia); 7 participants from the city of Sremski Karlovci (Serbia); 4 participants from the city of Zagreb (Croatia).

**Location / Dates:** The event took place online through the ZOOM platform and organised by GSI Italia on the 25<sup>th</sup> and 26<sup>th</sup> of August 2020.

**Short description:** The aim of the event was to identify:

- the steering group of general and country coordination
- the target population
- the information and awareness materials
- the internal communication, the decision making and the monitoring (monthly briefing skype)
- the monitoring and evaluation indicators
- to share the "animation" model and train 4 animators/country curated by the University of Camerino.

## <u>Event 1 – PROJECT ACTIVITIES: Organization and implementation of 10 DEBATES in each partner country</u>

**Participation:** The event involved 412 citizens.

The event involved 190 participants in Italy, including 71 participants from the Marche; 35 participants from the city of Nereto and 84 participants from the city of Foligno.

The event involved 71 citizens in Serbia, including 25 participants from the city of Novi Sad (Serbia); 22 participants from the city of Sremski Karlovci (Serbia); 2 participants from the city of Bac (Serbia); 7 participants from the city of Futog (Serbia); 7 participants from the city of Stara Pazova (Serbia); 8 participants from the city of Kragujevac (Serbia).

The event involved 75 citizens in Croatia, including 10 participants from the city of Samobor (Croatia), 60 participants from the city of Zagreb (Croatia) and 5 participants from the city of Slavonski Brod (Croatia).

The event involved 76 participants from the city of Novo mesto in Slovenia.

**Location / Dates:** The event took place online in all the partner countries due to the health measures concerning the Sars COV-2 pandemic.

The debates were organised from the University of Camerino (Italy) on 15.01.2021, 22.01.2021, 27.01.2021, 08.03.2021, 22.03.2021. They took place in Foligno (Italy) on 11.03.2021, 18.03.2021, 25.03.2021.

The event was organised from Sremski Karlovci, Serbia, from 01/11/2020 to 01/04/2021.

The event took place in Zagreb, Croatia, via Zoom platform, on 31.03.2021 and on 24.05.2021.

The series of events took place in Novo mesto, Slovenia, between 20/01/2021 and 06/04/2021.

**Short description:** The aim of the event was the organization of debates in schools and universities regarding the topic of Dublin treaty. With the help of animators/experts, young people discussed of Europe, starting from the Junker's White Book, of Euroscepticism and especially immigration. The experts introduced the Dublin regulations and EU policies to provide asylum protection, focusing on critical aspects of the question.

### **Event 2 - PROJECT ACTIVITIES: Organization and realization of a LABORATORY for each partner country**

**Participation:** The event involved 210 citizens.

The event involved 114 participants in Italy, including 59 participants from the Marche; 33 participants from the city of Nereto and 22 participants from the city of Foligno.

The event involved 30 citizens in Serbia, including 14 participants from the city of Sremski Karlovci (Serbia), 9 participants from Novi Sad (Serbia), 4 participants from Kragujevac (Serbia) and 3 participants from Stara Pazova (Serbia).

The event involved 36 citizens in Croatia, including 2 participants from the city of Slavonski Brod (Croatia), 4 participants from the city of Samobor (Croatia) and 30 participants from the city of Zagreb (Croatia).

The event involved 30 citizens from the city of Novo mesto in Slovenia.

**Location / Dates:** The event took place online in all the partner countries due to the health measures concerning the Sars COV-2 pandemic.

The event was organized from the University of Camerino (Italy) on 12.04.2021 and on 28.05.2021; it was organized by GSI Italia in Foligno (Italy) on 27.05.2021 and in Nereto (Italy) on 29.05.2021.

The event was organised on the 20th May 2021 in Serbia.

The event took place in Zagreb, Croatia, on 30.06.2021.

Two events took place in Slovenia, one online and one in the Youth Centre facilities of Društvo za razvijanje prostovoljnega dela Novo mesto, project partner from Novo mesto, Slovenia, the first one on the 06/04/2021 and the second one on the 27/07/2021.

**Short description:** The aim of the event was the elaboration of 10 Recommendations in each partner country. The participants made a synthesis of the key concepts emerged during the debates and in the collection of opinions through the social campaign, formalizing them in a document whose format was shared in the Kick-off meeting.

### <u>Event 3 - PROJECT ACTIVITIES: Organization and realization of a LABORATORY IN ITALY</u> with the participation of the partner countries

**Participation:** The event involved 60 citizens.

The event involved 23 participants in Italy, including 2 participants from the city of Spoleto (Italy); 20 participants from the city of Foligno (Italy) and 1 participant from the Marche (Italy).

The event involved 13 citizens in Serbia, including 1 participant from the city of Novi Sad (Serbia); 6 participants from the city of Sremski Karlovci (Serbia); 2 participants from the city of Futog (Serbia); 2 participants from the city of Stara Pazova (Serbia); 2 participants from the city of Kragujevac (Serbia).

The event involved 12 citizens in Croatia, including 5 participants from the city of Slavonski Brod (Croatia) and 7 participants from the city of Zagreb (Croatia).

The event involved 12 citizens from the city of Novo mesto in Slovenia.

**Location / Dates:** The event was performed on-line from Spoleto through the MEET platform and organised by GSI Italia, on 21/09/2021.

**Short description:** The aim of the event was to engage at least 10 young people per country to summarize the 4 starting documents on subjects related to Dublin Treaty to discuss the list of proposals on how to improve the existing procedures designed by the regulation. The 10 FINAL

RECOMMENDATIONS were the main result of this workshop, intended for the EC Bureau, the European Parliament and the parliamentarians/participating countries, a concrete participation from below in the political elaboration of the Union.

### **Event 4 - PROJECT ACTIVITIES: INFORMATION AND AWARENESS campaigns**

**Participation:** The event involved 400 citizens.

The event involved 191 participants in Italy, including 44 participants from the city of Castel Ritaldi (Italy), 130 participants from the city of Foligno (Italy) and 17 participants from the city of Nereto (Italy).

The event involved 69 citizens in Serbia, including 48 participants from the city of Sremski Karlovci (Serbia) and 21 participants from the city of Futog (Serbia).

The event involved 70 citizens in Croatia, including 5 participants from the city of Slavonski Brod (Croatia), 10 participants from the city of Rijeka (Croatia), 7 participants from the city of Osijek (Croatia), 4 participants from the city of Samobor (Croatia) and 44 participants from the city of Zagreb (Croatia).

The event involved 70 citizens from the city of Novo mesto in Slovenia.

### **Location / Dates:**

The event was organized in Italy as a live meeting in the library of the municipality of Castel Ritaldi on 18/09/2021 and in the Scientific High School of Foligno on 28/10/2021.

The event was performed in Serbia as a live meeting, organised in Danube 1245 Head Office on 14/10/2021 and 15/10/2021 and in Agricultural High School Futog on 20/12/2021.

The event took place in Zagreb, Croatia, via online Zoom platform due to the national health measures concerning the Sars COV-2 pandemic, on 23.11.2021.

The series of events took place online and in person in Novo mesto, Slovenia, on different dates: Week of Cultures Event on the 17/09/2021, Counter Euroscepticism Conference was on two dates, but we were presenting this project on the 26/11/2021 and the event in the School of Economics and Media took place on the 10/01/2022.

**Short description:** The aim of the event was a competition announcement for a social campaign on immigration / Dublin / Euroscepticism and the organization of installation of stands in order to inform wide public about the historical results and the benefits of the Union and the costs of its explosion and gathering opinions on Dublin, on European management of migrants and on Recommendations.

### **Event 5 - PROJECT ACTIVITIES: DISSEMINATION OF RESULTS**

Participation: The event involved 58 citizens.

The event involved 14 participants in Italy, including 9 participants from the city of Spoleto (Italy), 2 participants from the Marche (Italy), 2 participants from the city of Foligno (Italy) and 1 participant from the city of Nereto (Italy).

The event involved 6 participants in Serbia, including 3 participants from the city of Sombor (Serbia), 1 participant from the city of Novi Sad (Serbia) and 2 participants from the city of Sremski Karlovci (Serbia).

The event involved 12 citizens in Croatia, including 5 participants from the city of Slavonski Brod (Croatia) and 7 participants from the city of Zagreb (Croatia).

The event involved 26 citizens from the city of Novo mesto in Slovenia.

#### **Location / Dates:**

The event was organized in Italy as a live meeting on 18/09/2021 and on 28/10/2021; it was performed online on 18/01/2022 through a dissemination campaign.

The event was performed in Serbia as a live meeting, organised in the building of Province of Vojvodina, by Danube 1245 with help of Province Secretariat of Regional Development, Regional Cooperation and Local Self-Government on 13/12/2021.

The dissemination activities took place online in Croatia from 01/08/2020 to 27/12/2021. The event took place in Novo mesto, Slovenia, on 22/10/2021.

**Short description:** The aim of the event was the dissemination of project results to three actors: the European decision makers, the general public and the direct participants. The result on European decision makers was the attention to Recommendations: on the parliamentarians elected in the participating countries, the partners collected interviews on the feasibility of the Recommendations and their political sustainability. Social and media (press, TV, web) involved the general public. The participants, with the help of partners' mediators and secretariats, strengthened their awareness of political protagonism.
